## CEPNZ AGM CHAIRPERSONS REPORT

#### **Accreditation Document:**

Accreditation Document been finalised by Board.

Board currently finalising the process of accreditation. In general, all applicants would be required to undertake an interview, and initial registrations will be dealt with on a case by case process.

Process will be launched early in 2016, and fully functional by the end of March 2016, to coincide with the new financial.

Majority of the work over the past year by the board has been focused on the Accreditation Standards document. This have involved wide stakeholder consultation, both with members and the wider health sector.

A formal launch is planned for 2016, connecting to all health and allied health workforce groups.

#### Website:

New website was migrated from the HIRC Hub Site due to access issues through a change in the rules the ministry.

#### **Membership Fees:**
